Vistara, Air India to merger by March 2024; SIA to invest USD 250mn

Singapore Airlines Ltd (SIA) has said it would emerge as a 25.1% owner of Air India as part of a deal that would merge its Vistara full-service airline joint venture with Tata Sons into India's national carrier.

SIA will invest USD 250 million into Air India as part of the transaction, the Singaporean carrier said in a statement, with the pair aiming to complete the merger by March 2024 subject to regulatory approvals.





test results for tourists. Since then, there has been a rise in the number of passengers at Bangkok airport resulting in long passenger queues.
