FAITH urges Centre to open borders, extend e-visa & start overseas marketing

FAITH has urged the government for urgent reopening of India's borders to tourists and to permit all commercial flights to operate to full capacity to and from the country. Alongside, the umbrella industry association has requested for extension of the free e-visa from the currently announced



0.5 million for the whole duration of 2022-2024 till inbound travel recovers. A lot of countries have now opened or have announced opening up their borders to fully vaccinated travellers with the

impact of Omicron subsiding. FAITH has requested MOT to take up with Ministry of Health, the same for India and announce the opening up of our borders and resumption of full commercial flights with zero quarantine to fully vaccinated travellers across all Indian ports.

Finance Minister to bring up issue of bringing ATF under **GST** ambit with states

With growing fuel prices globally, the Union Minister of Finance Nirmala Sitharaman said she will bring up



the issue of bringing Aviation Turbine Fuel (ATF) under the Goods and Services Tax (GST) regime before the GST Council and the states.

The decision to include ATF in GST, she pointed out, was not hers alone to make. "It is for the GST Council to decide. The next time we meet at the Council, I will put it on the table for them to discuss it," she said, adding that she will also discuss the aviation sector's concerns with banks.



Time to remove the pre-departure testing requirement for fully vaccinated air travellers flying to the US: IATA



The International Air Transport Association (IATA), in partnership with Airlines for America (A4A) and 28 US and international aviation and travel and tourism stakeholder groups, urged the US government to remove the pre-departure testing requirement for fully vaccinated air travellers flying to the US. "The experience of Omicron has made it clear that travel restrictions have little to no impact in terms of preventing its spread. International travellers should face no additional screening requirements than what is applied to domestic travel.," said Willie Walsh, Director General, IATA.

Australia to reopen borders for fully vaccinated tourists only




Scott Morrison, Prime Minister of Australia has announced that the nation Down Under will open its borders to fully vaccinated tourists from February 21. This

development comes after two years when the country shut its orders due to the outbreak of Covid-19. Australia had one of the toughest restrictions to curtail the spread of the pandemic, and the measures were in force for nearly two long years.

"It's almost two years since we took the decision to close the borders to Australia," Morrison said.

This is a result of its parent company Genting Hong Kong filing for winding up operations two weeks ago after having failed to secure funding to stay afloat following the insolvency of its German shipbuilding subsidiary.

In a statement on January 28, Genting Hong Kong's appointed joint provisional liquidators said Dream Cruises filed to wind up the company with the Bermuda courts on January 27.

This is according to the agreement on the Facilitation of Visa Arrangements between both the governments, signed on the 17th of December, 2018.
