Relief at last! Government announces 27 March restart

After a gap of two years, India at last has lifted the ban on scheduled international flights. These flights, suspended because of the Coronavirus pandemic, will be operational from March 27.

``After having recognized the increased vaccination



coverage across the globe and in consultation with the stakeholders, the Government of India has decided to resume scheduled commercial international passenger

services to/from India from 27.03.2022, i.e. start of Summer Schedule 2022," said the Civil Aviation Ministry. Tourism stakeholders welcome the decision.

MoT invites comments from stakeholders on Draft National Digital Tourism Mission

The Union Ministry of Tourism has proposed setting up a National Digital Tourism Mission. In this regard, an inter-ministerial Task Force



has been set-up to undertake consultations with the tourism industry and domain experts, define the context, mission, vision, objectives, and overall scope of the National Digital Tourism Mission.

The Task Force has prepared a draft report on proposed National Digital Tourism Mission, which inter-alia lays down domain and technology principles, standards, digital stack, governance structure and plan for implementation. The Ministry of Tourism has invited final comments from the stakeholders on draft report for setting up of National Digital Tourism Mission.



EbixCash files draft papers with SEBI for INR 6,000-Cr IPO

EbixCash Ltd, the Indian subsidiary of Nasdaq listed Ebix Inc, has filed preliminary papers with capital markets regulator SEBI to raise INR 6,000 crore through an initial public offering (IPO). The funds will be garnered through fresh issuance of equity shares and there will not be

any offer-for-sale (OFS) component, according to the draft red herring prospectus. Also, the company may explore a pre-IPO placement of up to INR 1,200 crore. If such a placement is completed, the issue size will be used for four line the provide state of the p

be reduced. Proceeds of the IPO will be used for funding the working capital requirements of the company's subsidiaries — Ebix Travels and EbixCash World Money.



Global tourism expected to achieve 80% of pre-pandemic turnover in 2022

The global tourism industry is expected to achieve 80 per cent of the pre-pandemic turnover this year, revealed a report by Statista at the virtual ITB Berlin Convention, reports Trade Arabia. A significant improvement was already noticeable in 2021, a 36 per cent rise in growth compared with 2020. According to Statista's Mobility Market Outlook (MMO), last year the industry achieved a global turnover of around EUR 260 billion. This year, the figure will probably exceed EUR 353 billion, at 46 per cent rise, the highest growth rate in recent years. The MMO experts say a full recovery will not be achieved until 2024.

Of the one lakh people who visited the African nation from India every year in pre-Covid times, 9% flew from Bengaluru.

Neliswa Nkani, Hub Head of MEISEA, South African Tourism, said that her government is on track to roll out e-visas in India in the coming months. "At present, it takes not more than five days to get a visa, however introduction of e-visa will help expedite the process further," Nkani said

Malaysia to re-open borders for tourists on April 1

Malaysia will re-open to all vaccinated tourists from April 1, authorities said, joining a growing number of countries removing restrictions in an attempt to live with Covid. Having shut its borders on March 2020, tourists visiting Malaysia will now require only a negative Covid test to enter. "The government has decided to open its borders on April 1, 2022," Prime Minister Ismail Sabri said in media



briefing. "We believe this decision will boost our economy and help revive our ailing tourism sector," he said.
